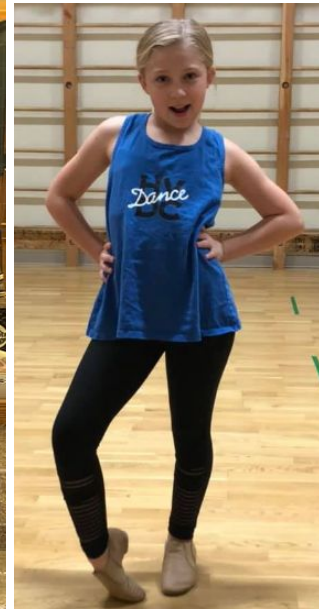

HIGH VELOCITY DANCE & DRILL INFORMATION

Thank you for your interest in our High Velocity Dance & Drill Program. If your child would like to be on High Velocity they will need to attend our dance bonding and skill assessment (or schedule a private assessment). **We would like to remind the athletes that being on High Velocity Dance Company is a privilege and should not be taken lightly. Generally, everyone who attends assessments will be placed on a team. However, there are times when we are unable to accommodate a student based on their age/ability level. Please note that all fees and deposits are non-refundable and non-transferable unless we are unable to place your child on a team.**

Our dance assessment process is not stressful! We evaluate in groups and encourage participants to retry their skills if they are not 100% satisfied with their performance. Once we have evaluated all of the dancers, we begin to assemble dance groups/routines. This is a very extensive and often complicated process. We must choose a well-rounded variety of dancers for each routine. We evaluate attitudes, potential, as well as current skills – because all are very important to us.

Auto-drafted between July 31st - August 3rd - Includes all choreography, music editing, and banquet

High Velocity Dance & Drill Tuition: \$85 per month

High Velocity Dance & Drill Annual Competition Fees: \$239 Due by November 2nd

Includes all competitions, recital, and coaching fees

High Velocity Dance & Drill Annual Costume: \$120 Due by November 2nd

PROGRAM COMPLIANCE & NO REFUND FORM

GymKix, L.L.C. and its representatives will not accept responsibility for injuries sustained by participants during the course of gymnastics, open workouts, or in the course of any exhibition, competition or clinic in which the member may participate or while traveling to or from an event. Any medical bills incurred for injuries sustained by a team member during the course of any of the above mentioned activities are the financial responsibility of the team member's parent/guardian.

With the above in mind, and being fully aware of the risks and possibility of injury involved, I consent to have my child/ren participate in the High Velocity Dance program. I, my executors or other representatives, waive and release all rights and claims for damages that I or my child may have against GymKix, L.L.C. and/or its representatives whether paid or volunteer.

I also affirm that I have and will continue to provide proper hospitalization, health and accident insurance coverage, which I consider adequate for my child's protection and my own protection. I fully understand that GymKix, L.L.C. staff members are not physician or medical practitioners of any kind. With that in mind, I hereby release the GymKix, L.L.C. staff to render temporary first aid to my child/ren in the event of injury or illness, and if deemed necessary by the staff to call a doctor and seek medical help, including transportation by a staff member or its representatives whether paid or volunteer, to any health care facility or hospital or the calling of an ambulance for the child.

I hereby give GymKix, L.L.C. the absolute right and permission to copyright and or publish or use photographic portraits, pictures, or videos of my child/ren, or in which he/she may be included in whole or in part, or composite or distorted in character or form, in conjunction with his/her own name or a fictitious one.

I have read and fully understand the policies and procedures that govern the GymKix, L.L.C. gymnastics program. I understand that failure to comply with these policies may result in dismissal from the program. I am in full compliance with all responsibilities and obligations that I am required to fulfill as a participant and agree to give my complete cooperation in order for the success of the program.

GymKix accepts monthly tuition through our convenient auto-debit program only.

GymKix will deduct monthly tuition and any other outstanding charges on the 16th of each month. Our After School Program is billed weekly (additional information available in our After School Information Packet).

We do not require your family to sign a contract for recreational programs; so cancelling, changing, or suspending your classes is easy and hassle-free. Simply visit the front desk or fill out our convenient online "Notice of Withdrawal" form at least one month prior to the final month of classes. Please refer to your competitive team policies for cancellation terms.

For Example: *Your family is moving in July, and you would like June to be your final month of classes: A "Notice of Withdrawal" must be submitted on/before June 1st so that you are not auto-debited on the June 16th (for July classes).*

I understand, agree, and will adhere to the payment policies listed above. I understand there may be up to a \$30 fee for credit cards or bank drafts that are declined.

I understand that no refunds will be given for failure to adhere to the cancellation policies listed above. If I fail to provide a 30-day written Notice of Withdrawal I will be charged for the next month. Additionally, I may be charged up to \$100 per routine for my child dropping before the end of the dance season.

I authorize GymKix to charge my credit card for monthly fees, merchandise purchased, Trophy's Health Bar Account Charges, and any applicable administrative and/or outstanding fees.
